ORDINANCE NO. 5-94

AN ORDINANCE AMENDING AN ORDINANCE OF YORKANA BOROUGH  
KNOWN AS THE YORKANA BOROUGH SIDEWALK ORDINANCE

WHEREAS, the Yorkana Borough has heretofore duly adopted an Ordinance dated June 16, 1913, regulating the construction and maintenance of sidewalks, curbs and pavements on and along the streets of the Borough of Yorkana; and,

WHEREAS, the Borough Council of the Borough of Yorkana has been advised by its engineers to adopt certain standards with regard to installing concrete curb and/or sidewalk; and,

WHEREAS, the Borough Council of the Borough of Yorkana is desirous of amending its Sidewalk Ordinance to incorporate therein the recommendations of their engineer.

WHEREAS, the Borough Council of the Borough of Yorkana is desirous of amending its Sidewalk Ordinance to provide for snow removal from sidewalks and/or a cleared pathway across each property.

NOW, THEREFORE, BE IT ENACTED, AND IT IS HEREBY ENACTED AND ORDAINED AS FOLLOWS:

1. Ordinance No. 2 dated June 16, 1913, relating to the grading, location and construction and maintenance of sidewalks, curbs and pavements on and along streets in the Borough of Yorkana, is hereby amended to add thereto specific drawings setting forth

the criteria for concrete sidewalks, for standard concrete curb details and for handicapped ramp details.

2. Snow must be removed from paved sidewalks to a width of 24 inches or in the event there is no paved sidewalk, a path 24 inches in width must be cleared across the property to provide for foot travel within 24 hours of the end of each snowfall.

3. Sidewalks shall be kept clear of all vehicles or other obstructions which impede pedestrian travel.

4. Anything contained in Ordinance No. 2 of 1913 inconsistent with the drawings and criteria set forth herein which is being made a part of the Ordinance this day shall not be enforceable, and construction shall occur as per the drawings amended to this Ordinance this date.

5. Penalty for Violation: Any person who constructs or fails to construct and maintain sidewalks, curbs and pavements contrary to this ordinance; or who fails to remove snow from sidewalks or clear a path 24 inches in width across property having no sidewalks; or who fails to keep sidewalks clear of vehicles or obstructions which impede pedestrian travel, shall be guilty of an offense, and upon conviction thereof before a District Magistrate in a summary proceeding, be sentenced for each such violation to pay a fine not exceeding Three Hundred and 00/100 (\$300.00) Dollars and costs of such proceedings and in default thereof undergo imprisonment for a period not exceeding thirty <sup>(30)</sup>~~(6)~~ days.

The amendment shall be effective upon enactment.
