

AN ORDINANCE PROHIBITING DISORDERLY
CONDUCT AS DEFINED HEREIN, IMPOSING
PENALTIES FOR THE VIOLATION THEREOF

BE IT ORDAINED by the Borough Council of the Borough of Yorkana and it is hereby ordained by the authority of the same as follows:

SECTION 1: This ordinance shall be cited as the "Disorderly Conduct Ordinance".

SECTION 2: It shall be unlawful for any person, persons, partnership, corporation or business entity to commit or cause to be committed any act or acts of disorderly conduct as defined herein within the Borough limits of Yorkana, County of York, Commonwealth of Pennsylvania.

SECTION 3: The following acts shall be defined and declared to constitute disorderly conduct and shall be in violation of this ordinance.

A. Refusing to obey any lawful orders issued by any police officer of Yorkana Borough while in the performance of his duties.

B. Appearing in a drunken or intoxicated condition in or about any public street, alley, lane, bar, square, common or recreational area, public buildings, lodge or fraternal organization grounds or any other area not specifically designated as private or to which the public shall have access.

C. Uttering of profane, opprobrious, scandalous, obscene or indecent language to any police officer of the Borough, public official or the uttering of any profane, opprobrious, scandalous, obscene or indecent language in any areas as more fully defined in paragraph B preceding.

D. Engaging in fighting in or about any area designated in paragraph B preceding.

E. Making or causing to be made any loud or boisterous noise or disturbance to the annoyance of the peaceful residents nearby, or near or on any public highway, road, street, lane, alley, park, square, common or recreation area or anywhere else whereby the public peace is broken or disturbed or the traveling public annoyed.

F. Prowling or loitering about the property of other persons, peeping into any house, or other structure without the consent of the owner, provided, however, that this shall not be so construed to prohibit peaceful picketing upon the public highway or sidewalks in the case of a legitimate labor dispute.

G. Loitering or being found in any place in which acts of prostitution or lewdness or solicited practice are encouraged or inveigling or enticing of any female person by a male person to accompany him in a vehicle.

H. Throwing or depositing in or on or about any public street, alley, park, lanes, square or any other place to which the public has access any waste, paper, sweepings, ashes, household waste, glass, metal, refuse, rubbish, garbage or dangerous or detrimental substance.

SECTION 4: Any person or persons who shall violate any of the terms or provisions of this ordinance shall, upon conviction thereof before any District Magistrate of Yorkana Borough, be sentenced to pay a fine of Twenty-Five (\$25.00) Dollars, plus costs of prosecution for the first offense and Fifty (\$50.00) Dollars plus costs of prosecution for the second offense and a penalty of ~~one hundred Dollars~~ ^{Dollars} plus costs of prosecution for each subsequent offense, to be collected as other fines and costs are now by law collectable and in default of payment of said fine and costs shall be imprisoned in the York County jail for a period not exceeding thirty (30) days.

SECTION 5: If any provisions of this Ordinance or application thereof, any person shall be held invalid, the remainder of this ordinance and the application of such provisions to the other persons shall not be effected thereby and to this end the provisions of this ordinance are declared to be severable.
